VII. NEW BUSINESS:

a. Selection of 202 Nationals from bids received:

i. 2025 WESTERN NATIONAL BIDS (West Central District / Ashley Foutch)

1. The board reviewed the two bids received for the 2025 Western National from both the Nebraska State Poultry Association and the Minnesota State Poultry Association. After a lengthy discussion of factors including kickbacks to the club, time of year, expected turnout, and times host clubs have had the national before a vote from each board member was cast. It was determined that the Minnesota State Poultry Association would be the host club of the 2025 Cochin International Western National Meet.

ii. 2025 EASTERN NATIONAL BIDS (Northeast 1 District):

- 1. Only one bid for the 2025 Eastern National was received and reviewed by the Board. The bid was received from the Virgina Poultry Breeders Association.
 - a. Tom Roebuck shared he didn't believe the turnout would be very good due to the 15-day prior AI requirement needed to be able to show in Virgina, but stated the show does have a good show hall. Rich Barczewski commented that requirements can be met if exhibitors are committed to getting it completed.
- Rich Barczewski motioned to grant the Virgina Poultry Breeders
 Association the 2025 Eastern National Bid. Mike Becker seconded the
 motion. There was no discussion, all were in favor, and none were
 opposed.
- iii. President, Gail Carlson stated to keep results confidential until she has contacted all shows. She will email all clubs who placed a bid within 24 hours of the conclusion of this meeting.

b. FINAL NOTES:

- i. President, Gail Carlson's final notes:
 - 1. Directors have \$200 to spend for District Meet and \$800 to spend for National Meets.
 - 2. Board Members need to get good receipts now with the club having 501 (c) (3) status.
 - 3. Articles due 15th of August for the September 1st, 2024, issue.
 - 4. If any Board Member is re-running for office, letter of intent is due August 15th, 2024.
 - 5. Asked the for Board for permission to use Linda Blackman as the election judge again, and all agreed.
 - 6. If merchandise is needed, get list to Gail Carlson sooner rather than later and cost of shipping keeps going and rather not have to pay for expediated shipping.
