Below you will find information on the Avian Influenza:

Protecting Birds from Avian Influenza:

Q: I have a back yard flock. How can I protect them from avian influenza?

- **A:** USDA recommends that owners of **backyard flocks** follow these six tips to prevent poultry disease:
- Keep your distance (restrict access to your property and your birds);
- Keep it clean (clean and disinfect your clothes, shoes, equipment, and hands);
- Don't haul disease home (if you have been near other birds or bird owners, clean and disinfect poultry cages and equipment before going home);
- Don't risk disease from your neighbor (do not borrow lawn and garden equipment, tools, or poultry supplies from other bird owners);
- Know the warning signs (sudden increase in bird deaths, sneezing, coughing, nasal discharge, watery or green diarrhea, lack of energy, poor appetite, drop in egg production, swelling around the eyes, neck, and head, and purple discoloration of wattles, combs, and legs); and report sick birds (call your local or State veterinarian, or USDA toll-free at 1-866-536-7593).

Q: What can poultry producers do to prevent an AI outbreak on their farms?

- **A: Poultry producers** should strengthen bio-security practices to prevent the introduction of AI into their flocks. The following are some sound bio-security practices:
- Keep an "all-in, all-out" philosophy of flock management. Avoid skimming flocks—birds left behind are exposed to work crews and equipment that could carry poultry disease viruses. Process each lot of birds separately, and clean and disinfect poultry houses between flocks.
- Protect poultry flocks from coming into contact with wild or migratory birds. Keep poultry away from any source of water that could have been contaminated by wild birds.
- Permit only essential workers and vehicles to enter the farm.
- Provide clean clothing and disinfection facilities for employees.
- Thoroughly clean and disinfect equipment and vehicles (including tires and undercarriage) entering and leaving the farm
- Do not loan to, or borrow equipment or vehicles from, other farms.
- Change footwear and clothing before working with your own flock after visiting another farm or live-bird market or avoid visiting another bird farm if possible. Do not bring birds from slaughter channels, especially those from live-bird markets, back to the farm.

If avian influenza is detected, farms must be thoroughly cleaned and disinfected. Avian influenza viruses are inactivated by heat and drying and also these viruses are very sensitive to most disinfectants and detergents. The area to be

disinfected must be clear of organic material, which greatly increases the resistance of avian influenza virus' resistance to disinfection.

Q: What should producers do if their birds appear to have signs of avian influenza?

A: If birds exhibit clinical signs of highly pathogenic avian influenza or might have been exposed to birds with the disease, producers or bird owners should immediately notify Federal or State health officers. All bird owners, whether commercial producers or backyard enthusiasts, should continue to practice good bio-security, prevent contact between their birds and wild birds, and report sick birds or unusual bird deaths to State/Federal officials, either through their state veterinarian or through USDA's toll-free number at 1-866-536-7593. Avian Influenza in the United States

Q: Does highly pathogenic avian influenza currently exist in the United States?

A: Since mid-December 2014, there have been several ongoing highly pathogenic avian influenza (HPAI) H5 incidents along the Pacific, Central and Mississippi Flyways. Cases in wild birds, captive wild birds, backyard poultry or commercial poultry have been reported in Arkansas, California, Iowa, Idaho, Kansas, Minnesota, Missouri, Montana, North Dakota, Nevada, Oregon, Utah, South Dakota, Washington, Wisconsin and Wyoming. Details are available on the <u>APHIS website</u>.

The HPAI strains detected recently in these flyways are H5N2, H5N8 and H5N1, but primarily H5N2 in turkey flocks.

Q: Can people catch these highly pathogenic avian influenza strains that are being detected in these outbreaks?

A: CDC considers the risk to people from these HPAI H5 viruses in wild birds, backyard flocks, and commercial poultry, to be low. No human infections with these viruses have been detected at this time; however, similar viruses have infected people. It's possible that human infections with these viruses may occur. While human infections are possible, infection with avian influenza viruses in general are rare and – when they occur – these viruses have not spread easily to other people. These reports of H5-infected wild birds and poultry in the United States do not signal the start of a pandemic.

Q: How is USDA dealing with these HPAI outbreaks?

A: The United States has the strongest AI surveillance program in the world so that the food supply remains safe. One, in which USDA actively looks for the disease as well as provides compensation to affected producers to encourage reporting. As part of the existing USDA avian influenza response plans, Federal and State partners as well as industry are responding

quickly and decisively to these ooutbreaks by following these five basic steps:

- Quarantine restricting movement of poultry and poultry moving equipment into and out of the control area:
- Eradicate humanely euthanizing the affected flock(s);
- 3) **Monitor region** testing wild and domestic birds in a broad area around the guarantine area;
- 4) **Disinfect** kills the virus in the affected flock locations; and
- 5) **Test** confirming that the poultry farm is AI virus-free.

Q: Has HPAI ever occurred in this country before these 2014/2015 outbreaks?

- **A:** Incidents of low pathogenic avian influenza are commonly detected in domestic poultry flocks. Low pathogenic avian influenza does not pose a serious threat to human health.
- USDA has experience responding to highly pathogenic avian influenza in U.S. poultry. Before these current outbreaks, there were only three high path AI outbreaks in commercial poultry in U.S. history – in 1924, 1983 and 2004. No significant human illness resulted from these outbreaks.
- The 1924 H7 HPAI outbreak was detected in and contained to East Coast live bird markets.
- The 1983-84 H5N2 HPAI bird outbreaks resulted in the destruction of approximately 17 million chickens, turkeys, and guinea fowl in the northeastern United States to contain and eradicate the disease.
- In 2004, USDA confirmed an H5N2 HPAI outbreak in chickens in the southern United States. The disease was quickly eradicated thanks to close coordination and cooperation between USDA, state, local, and industry leaders. Because of the quick response, the disease was limited to one flock.

<u>Avian Influenza and USDA's Role in Protecting the United States</u>

Q: What is USDA doing in response to the HPAI outbreaks in the United States?

- **A.** USDA recognizes that highly pathogenic avian influenza poses a significant threat to animal health. Accordingly, USDA has safeguards in place to protect against and respond to highly pathogenic avian influenza in the United States. In the current response effort, USDA is coordinating closely with State officials (in affected and bordering States) and other Federal departments on avian influenza surveillance, reporting and control efforts. USDA also is coordinating with Canada on the HPAI H5 findings that are close to the Northern U.S. border.
- Q: What is USDA doing to help States and producers?
- **A:** USDA will continue to do everything it can to support states and producers. USDA will continue to coordinate closely with State officials and other Federal departments on rigorous surveillance, reporting and control efforts. At the same time, USDA will continue to work with Congress to ensure that we are able to provide a much-needed safety net to the poultry producers who are experiencing economic hardships as a result of losses due to the disease.

Q: What does USDA do besides respond to HPAI outbreaks are there other systems in place?

A: <u>Trade restrictions</u>: USDA maintains trade restrictions on the importation of poultry and poultry products from countries and/or regions where there have been confirmed outbreaks of highly pathogenic avian influenza in commercial or traditionally-raised poultry.

Surveillance: USDA works with Federal and State partners and Industry to monitor U.S. bird populations. Surveillance is conducted in four key areas: live bird markets, commercial flocks, backyard flocks, and migratory bird populations. Extensive testing occurs in live bird markets and commercial flocks. Additionally, birds that show signs of illness are tested. USDA and State veterinarians are specially trained to diagnose foreign animal diseases, such as avian influenza and regularly conduct field investigations of suspicious disease conditions. This monitoring is assisted by university personnel, State animal health officials, USDA-accredited veterinarians, and members of the industry who report suspicious cases. USDA and State animal health officials work cooperatively with the poultry industry to conduct surveillance at breeding flocks, slaughter plants, live-bird markets, livestock auctions, and poultry dealers.

Backyard flock bio-security program: USDA encourages backyard and small poultry producers to strengthen bio-security practices in order to prevent the introduction of AI into their flocks. Bio-security refers to practical management practices that help to prevent diseases.

Q: Is USDA doing any work globally?

- A: USDA is working closely with international organizations such as the World Organization for Animal Health (OIE), the United Nations Food and Agriculture Organization (FAO), and the World Health Organization to assist HPAI-affected countries and other countries with disease prevention, management, and eradication activities. By helping these countries prepare for, manage, and eradicate HPAI outbreaks, USDA can help to slow the spread of the virus. Some efforts include:
- Training sessions for veterinarians and poultry disease experts from H5N1-affected and at-risk countries to teach testing protocols;
- Professional expertise and funding to help the FAO in Rome develop a new Crisis Management Center, to respond rapidly and effectively to avian influenza outbreaks in poultry worldwide;
- Assistance to H5N1-affected countries, including laboratory equipment, reagents, and sample shipping containers to bolster AI testing and diagnostic programs;
- 4) In collaboration with FAO and OIE, USDA has deployed expert scientists, veterinarians, and animal health emergency managers to HPAI-affected countries to test and diagnose AI; advise on surveillance and vaccination programs to protect poultry; and advise on emergency contingency plans.

Highly Pathogenic Avian Influenza - Frequently Asked Questions - Updated March 27, 2015

1. What is Avian Influenza?

- Avian Influenza (AI) is a viral disease that affects all species of birds. It is caused by the type "A" influenza virus.
- AI viruses can be classified into two categories, those that cause mild to no disease in poultry (low pathogenic avian influenza or LPAI) and those that cause severe disease (highly pathogenic
- avian influenza or HPAI).
- Waterfowl are the natural reservoirs (carriers) of AI viruses.
 While the viruses may cause marked illness and fatality in domestic poultry, waterfowl often show little to no signs of infection.

2. What are the signs of HPAI?

- Some birds may exhibit flu and cold-like symptoms. Signs may include: loss of appetite, lack of vocalization, drop in egg production, coughing, swollen face, diarrhea and paralysis.
- Sudden and rapid death loss.

3. How is HPAI spread?

- AI is spread easily through droppings or nasal discharge of and infected bird, which contaminates dust and soil.
- People can carry the virus on their shoes, clothes, equipment and vehicles.
- Control methods are limited; therefore, it is better to prevent infections with bio-security at an individual farm and regional level. Influenza viruses follow the movement of people and equipment and can only be controlled if everyone communicates openly.

4. Does it affect people? Can people get AI from eating poultry?

- The risk of human infection is very low. To date, the HPAI strains that have been found in the United States have not been detected in humans.
- Risk of infection is limited to people in direct contact with affected birds.
- All poultry identified with HPAI are prohibited by law from entering the marketplace.
- There is no evidence that people can acquire AI by eating poultry products.
- As a reminder, all poultry and eggs should be handled properly and cooked to an internal temperature of 165° F.

5. What is being done to prevent and stop the spread of HPAI?

- Early detection is the key to preventing the spread of the virus.
- Minnesota's AI surveillance program has been in place for more than 40 years.
- Every commercial poultry flock in Minnesota is tested for influenza by the Board of Animal Health prior to going to market. Some smaller poultry flocks and live bird markets in Minnesota also participate in AI surveillance programs. The United States has the strongest AI surveillance program in the world. The USDA along with poultry industry partners are actively looking for the disease.
- In Minnesota, the Board of Animal Health immediately quarantines potentially-infected flocks and collects samples for AI testing.
- Once a flock is confirmed positive, the Board and the USDA work with the producer/bird owner to create a flock plan. The

- plan includes appraisal, indemnity and depopulation of remaining birds, carcass disposal and cleaning and disinfection of the premises.
- To meet federal requirements for HPAI response, the Board also conducts surveillance testing within 10 km of the affected farm and notifies all other poultry owners within a 20 km area.

6. What role do waterfowl play in the spread of HPAI?

- Waterfowl are the natural reservoirs (carriers) of AI viruses.
- Ultimately wild birds are involved as a reservoir but the specifics
 of how this virus got into this house is an ongoing investigation.
 What we do know is that there is nothing that can be done
 about what is happening in wild birds. What can be done,
 however, is that owners of domestic poultry can use bio-security
 to protect their flocks.

7. What is Bio-security?

 Bio-security is a term used to describe the procedures and practices that are followed by the poultry industry in order to contain or prevent the spread of influenza viruses in a poultry flock. These practices include isolation, sanitation and traffic control of people, animals and equipment.

8. What steps can I take to protect my flock(s)?

- Discourage co-mingling of waterfowl and domestic birds and poultry. This includes eliminating feed or water available which attracts waterfowl and other wild birds.
- Avoid on-farm traffic patterns that cross waterways. Wear appropriate footwear that can be cleaned and sanitized.
- Prevent access to surface water and the surrounding environment by poultry and prevent wild birds access to poultry feed, water and other environments strictly for poultry.
- Avoid the use of surface water for watering poultry unless it has been treated and disinfected.

9. What should I do if I observe signs of illness or increased mortality in my birds?

bird & rodent control measures the Center for Food Security & Public Health IOWA STATE UNIVERSITY®

Disease causing organisms can be carried on the fur, feathers or feet of some animals. Birds and rodents can spread disease for a short time and distance and can also contaminate feed and water sources with their urine and/or feces. Control programs should be implemented to minimize their numbers and the risk of disease spread on your farm.

1. Eliminate openings for rodents or birds to enter, especially feed storage or processing areas.

- Seal any opening greater than ¼ to ½ inch with a durable material such as steel wool packed tightly into openings.
- Use materials that cannot be easily gnawed or pecked through such as concrete, sheet metal, wire mesh, aluminum or brick.
 Plastic sheeting, wood, rubber will not be adequate.
- Check openings around augers, pipes and wires. Use mortar, masonry or metal collars in these areas.

- Doors, windows and screens should fit tightly. The distance between the bottom of the door and threshold should not exceed ¼ inch.
- Drainage pipes or sewage systems may be used by rodents as routes to enter buildings. Equip floor drains with metal grates (openings less than ¼").

2. Remove potential hiding, resting and nesting sites.

- Equipment (e.g., refrigerators, power washers, etc.) should be raised and easily movable to allow for easy cleaning be-hind and underneath them.
- Sacked feed should be stacked on pallets with adequate space around and under them to allow easy inspection for signs of rodent activity and trap or bait placement.
- Rats can burrow and nest under feed bunks placed directly on the ground. Use of a concrete base around feed bunks can eliminate habitat.

- Maintain the water level in livestock waterers so it is deep enough that birds cannot stand in it.
- Hanging strips of heavy plastic vertically in doorways of buildings will allow machinery and people to pass through but keeps birds out. This will not prevent rodent entry.
- Cover the undersides of rafters with netting to exclude birds from nesting sites.

3. Eliminate potential food sources.

- Store feed in well sealed containers (preferably metal with tight fitting lids).
- Use covered feeders that exclude birds.
- · Clean up any spilled feed immediately.
- Proper disposal of garbage and dead animals is a very important part of rodent control.

5. Establish a rodent barrier around buildings.

- A 3 foot wide weed free area with a gravel rock perimeter can be used to prevent weed growth and discourage rodents from burrowing
- Gravel (at least 1 inch diameter) should be placed in a band at least 3 foot wide and 6 inches deep.

6. Trapping is an effective way to control rodents.

- Proper placement of traps and baits is important. Set traps close to walls, behind objects, in dark corners, in places where rodent activity is evident.
- Use talc or flour patches to track where rodents are active.

7. Baiting may be used to control rodents.

- When using rodenticide baits, first read the label carefully and fully follow the directions.
- Use the amount of bait indicated on the package. Requirements differ between products.

- · Protect baits from the weather.
- Be sure baits are not accessible to children, farm or domestic animals and birds.
- Inspect baits regularly. Check often for dead rodents and burn or bury those you find.
- 8. Other control measures are available, but beyond the scope of this document. Contact a wildlife pest control operator in your state for further assistance.
- Check local legislation for allowable bird control measures. Many birds are protected by state and/ or federal law.



I called the Michigan Dept. of Agriculture and Rural Development yesterday to verify and all is true. They said that there have been no cases of Avian Influenza in Michigan and that this is a precautionary measure. If anyone has questions they can get on the MDARD website or call 1-800-292-3939. I mentioned to them about our Fowl Fest show that is held here in the Fall, and they said that will not be allowed. Also in similar press releases from yesterday that I read: Indiana and Ohio have decided to do the same thing and allow no exhibition of poultry, no intermingling which also includes fairs and swap meets for the 2015 year.

MDARD's State Veterinarian Stops Bird Movement to Protect Health of Michigan Poultry

Agency: Agriculture and Rural Development

Due to the potential for highly pathogenic avian influenza, 2015 poultry exhibitions are canceled throughout the state

Lansing – Today, after much deliberation and consideration with the Michigan Association for Fairs and Exhibitions (MAFE), Michigan 4-H leadership and the Michigan Allied Poultry Industry, the Michigan Department of Agriculture and Rural Development's State Veterinarian Dr. James Averill made the difficult decision to cancel all 2015 poultry and waterfowl exhibitions in Michigan to prevent the comingling of birds from different locations. This includes, but is not limited to shows, exhibitions, swap meets, petting zoos at fairs, game bird and waterfowl fair displays, and Miracle of Life exhibits.

"We know the tremendous amount of time, money and passion the kids and other exhibitors invest into their birds and the importance of having livestock animals at these events to interact with the public," said Averill. "The rapid spread of these avian flu viruses is historic and has impacted more than a dozen states across the U.S. While there are currently no known cases of HPAI in Michigan, commitment to protecting the health of all of the state's poultry flocks - backyard and commercial farmers - led us to making this difficult decision."

MDARD has been working in conjunction with the Michigan Association of Fairs and Exhibitions, Michigan State University Extension, 4-H programs, and other partners to identify ways to engage Michigan's youth poultry exhibitors and allow them to still have the experience.

"The impact this disease has had on the poultry industry and how quickly it is spreading is clear," said Lisa Reiff, MAFE Executive Director. "While it's unfortunate that poultry exhibitions are canceled for this year, its crucial youth still have an opportunity to participate in fair activities. MAFE is working with MDARD, MSU and 4-H to identify alternatives for poultry exhibitors and will use this opportunity to help further educate the public about our state's poultry industry."

County fairs and local exhibitors are encouraged to go to the MSU Extension website - msue.msu.edu/poultry shows - to get a list of options for poultry exhibitors. Those options include suggestions for showmanship, breed classes, market classes and auctions.

MDARD, the Michigan Department of Natural Resources, Michigan Department of Health and Human Services, U.S. Departments of Agriculture Veterinary Services and Wildlife Services, and MSU are working together to conduct avian influenza surveillance and to monitor health of poultry, livestock, wildlife and residents in Michigan.

- Michigan residents who notice the death loss of three or more WILD birds should report it to DNR at 517-336-5030.
- If your backyard poultry flock has a high death loss or consistent pattern of death loss in a short period of time, report it to MDARD at 800-292-3939; (after hours emergencies) 517-373-0440.

NE II Report - Rich Barczewski:

Things are going good here in NE II but being in the district of Cochins International that has the most stringent Avian Influenza regulations in place, I have to tell you that we are watching carefully the progression of the disease in the Western and Central regions of the country. I remember about 10 years ago, being told by fairly popular person from the Midwest that we would never see the testing requirements in the Midwest that were being imposed on us in the East. That still remains to be seen.

All indications are that Avian Influenza will arrive in the Eastern US in the fall, coupled with the fall migrations of wild waterfowl. With that in mind, I think it may be a good idea to go over a few bio-security points in this report.

I don't know about you, but I have 15 years of my life invested in developing my genetic line of Partridge Cochins. I can't tell you how many birds I've raised over those years, nor can I tell you how many dollars I have invested in them, but what I can tell you is that I am going to do whatever I can to keep them safe.

In order to do that, I think it is important to pay close attention to what is going on with the disease, where it is currently being found and how is it progressing. USDA has been tracking the disease if you go to the APHIS Web site you can follow the progression of the disease.

Personally, I am starting to pull back in my willingness to travel to areas close to where the disease can be found. The way I look at it, the closer you get to regions where the disease can be found, the more likely you may come in contact with birds that may be from the infected region. This particular disease is highly contagious so if an infected bird showed up at a poultry show, it would most likely infect other birds that are cooped near it. Those birds in turn would potentially find their way home to infect other birds and the disease would continue to spread.

Each of us has to be careful and make our own decisions as to when we decide that going to a show or swap or sale isn't worth it anymore because of the risk. For me, I would rather err on the side of caution. My birds are just worth too much to me.

On a lighter note, I hope all is going well in your breeding pens. I hatched out about 20 large fowl early and hope to have an additional 40 or so out in the next week or two. Members should be aware that Cochins International has a Facebook page where you can go to share ideas and ask questions. Sometimes you may get an answer that you don't like but realize that there are some very good breeders out there that cruise through the site from time to time and will often share some good advice. Keep checking back. I have placed special meets at Sussex County, NJ, Uniontown, PA and Central PA (Bloomsburg) for the spring. If anyone need, me to place a meet at a show in the district, just let me know. The easiest way to contact me is through email richbar302@gmail.com. Until next time, keep those cochins on Champion Row!



Those of us who do our hatching only in the spring will be starting to finish up for this year. My favorite time of year as a breeder is when the meticulous work of setting up breeding groups, collecting eggs, hatching and brooding is finally finished. I find summer to be a less intense time...but still a time of anticipation and excitement as those little balls of fluff grow and develop, with hopefully a few becoming outstanding young adults. The hope, for many of us, is that we'll have some promising show prospects from this year's hatch.

At the mention of poultry shows, Avian Influenza is weighing heavily on everyone's mind. The threat of AI has resulted in several Ontario shows being canceled recently. It's a good idea to check ahead before booking time off work or making travel plans to attend the usual annual shows.

I hadn't meant to deal much with the AI outbreak in this article. But after reading a comment on the APA Facebook group page I decided to remark on the impact of this dreaded disease as it applies to exhibition poultry. The Facebook post was announcing that all competitions have now been banned in New York, and for the most part people responded with feelings of regret. But one person wrote, "This is good thing. Protecting the states flocks is far more important than silly shows."

Now, of course we all agree that stopping the spread of disease is paramount. But using the word 'silly' to describe poultry shows...that got my back up a bit. In October of 2005, Edmonton Northlands Park announced that their poultry and pigeon show, which had been a long standing part of Farmfair International, was canceled. This was the primary Alberta show at the time, and organizers had been expecting 3,000 pigeons and hundreds of poultry entries. The press release stated that the bird show was called off as a "proactive measure to protect public and agricultural interests in light of worldwide concerns over Avian Influenza".

While the virus itself has the potential to be devastating to our flocks, the loss of shows can also be incredibly detrimental to the hobby, and consequently to the overall quality of our cherished poultry breeds. The Edmonton Northlands Poultry Show has never returned, and it has taken many years for other clubs to gather the momentum to step in and try to fill the void left by that loss.

We should not take our poultry shows for granted. They serve such an important role far beyond the camaraderie and fun of friendly competition. There is so much to be gained from talking with judges, making connections with other breeders and striving to excel in our breeding endeavors as we compare our best with that of our fellow exhibitors. Keeping our poultry shows strong and well attended is critical to our hobby and to the future of standard bred poultry.

During the summer months there will be many opportunities to attend fairs and APA Poultry Shows in several provinces across Canada in locations where AI is not considered a risk. These shows need our support and encouragement to continue. And even if you are in a quarantined area, you can still take part in the CI Online Shows. We are so fortunate to have a strong, dynamic club with great membership benefits such as the Online Shows.

In closing, please let me know what is happening in your area, and if you'd like to host a CI meet in conjunction with your club's show.

Code of Conduct Disciplinary Action:

The Board of Directors recently took action to remove a member from our rolls. A formal hearing, as prescribed by ARTICLE VI, Section 4, of the Disciplinary Actions of the Constitution was held concerning the conduct of a COCHIN member. Evidence was presented and discussed followed by an oral vote of Board of Directors. The member in question was permanently expelled from the organization.

The Board of Directors of Cochins International takes issues of member conduct very seriously and feels that only in the most extreme circumstances should a member be sanctioned or removed from the club. Unfortunately, recent occurrences by one of our members have resulted in the Board taking action to remove that member from our rolls. A formal hearing, as prescribed in Article VI, Section 4 of the Disciplinary Actions of the Constitution was held concerning the conduct of one of our members. Evidence was presented and discussed and followed by an oral vote of the Board of Directors. The vote resulted in the member in question being permanently removed from our organization. No member should ever have to worry about being barred from an organization, however, when individuals act in such a way that is contrary to the purpose and function of the organization, or negatively impacts other members, action must be taken to preserve the integrity of the organization.

CODE OF CONDUCT - Article VI of Cochins International By-Laws

In order to promote values such as integrity, service and friendship, education in promoting purebred poultry and to maintain consistency throughout the poultry fancy, Cochins International will adopt the American Bantam Association (ABA) Code of Conduct as follows:

Purpose:

- 1. Provides a democratic and orderly process to address activities that may have a negative impact to the integrity, operation and long term health of Cochins International.
- 2. Promotes values that maintain the strength and longevity of Cochins International.

Grounds for Disciplinary Actions:

- 1. Theft or any other actions that impact or compromise the financial integrity of Cochins International.
- 2. Organized or individual attempts to purposely slander or discredit the integrity or stature of Cochins International, its Officers, Regional Directors and/or the general membership.
- 3. Misrepresentation of Cochins International credentials, logo, property, etc., for the purpose of personal gain.
- 4. Discrimination and harassment based on race, color, religion, gender, sexual orientation, national origin, or any other class.

- 5. Violence or threats of violence.
- 6. Any additional actions that result in significant negative impact to Cochins International.

Procedures for Addressing Code of Conduct Violations:

- 1. The Board of Directors will conduct an appropriate hearing to validate or disprove any of the above violations.
- 2. The discussion/hearing shall be held at the next scheduled meeting of the Board of Directors. (If there is an immediate need to discuss or address an urgent issue, other forms of Cochins International / May, 2014 Page 7 communication/discussion may be used including e-mail, phone, conference, etc.)
- 3. Recommended disciplinary actions must be passed by a majority vote of the Board of Directors of Cochins International.
- 4. Disciplinary steps as agreed upon by majority vote will be communicated by the President of Cochins International.

Disciplinary Actions:

Any member who fails to maintain adherence to the Cochins International Code of Conduct is subject to disciplinary action, including but not limited to the following in any order or combination:

- 1. Verbal warning issued by any member of the Executive Board of Cochins International.
- 2. Written warning issued by Cochins International.
- 3. Membership suspension for six months or greater.
- 4. Permanent membership suspension.

All final disciplinary actions and decisions are up to the complete discretion of the Board of Directors of Cochins International.

Junior Master Exhibitor Status is earned when a junior member earns 5,000 points and there are no time limits for completion.

In addition to the new Junior Master Exhibitor Program, Junior members of Cochins International may earn achievement pins for Best of Breed or Reserve of Breed wins with their cochins in either an Open or Junior APA/ABA sanctioned show. Master Breeder and Merit Award Program

We have a well established Master Breeder Program, whereby members earn points based on the number of Cochins exhibited at shows which host Cochins International meets. There are currently three Master Breeder point total recognition levels:

Gold: 500 Points Earned in One Variety / Master Breeder Status and Plaque 250 Points Earned in One Variety / Merit Certificate of Achievement

Bronze: 100 Points Earned in One Variety / Merit Certificate of Achievement

Master Breeder points will be allowed for all recognized and non-recognized color Varieties of Cochins and points can only be gained within the breed.

- The program is based on one point for every five birds shown.
- ❖ The ultimate goal is 500 points in not less than five years in any one variety.
- Membership must be current to qualify for Master Breeder points. If an individual has lapsed membership for one year or more, the points will be removed from the records unless all absent years' of outstanding membership dues are paid back in full.
- NOTE: For historical purposes, former members achieving 100 or more points in a variety will be recorded and maintained indefinitely.

Points are accumulated as follows:

- Master Breeder upon achieving 500 points in no less than five (5) years.
- One point is earned for every five Cochins exhibited for Best and Reserve of Variety.
- One point is earned for every five Cochins exhibited for Best and Reserve of Breed.
- One point is earned for every five Cochins exhibited for Overall Champion (FL and Bantams).
- There must be at least five Large Fowl and five Bantam Cochins in competition.
- The points are awarded for the highest win an individual bird earns in its class.
- A Certificate of Merit will be awarded for the first One Hundred points (100 pts) in any variety.
- Merit Certificate of Achievement will be awarded for the first Two Hundred and Fifty (250 pts) in any variety.
- Master Breeder status is earned upon reaching 500 points in a variety and a plaque is awarded to recognize this achievement.

Cochins International Junior Program

The purpose of the CI Junior Program is to promote and encourage junior members to:

- Participate in exhibiting bantam and large fowl Cochins
- Gain knowledge on the proper care of Cochins and the value of breeding to the standard
- Learn good sportsmanship skills

Junior Master Exhibitor Program:

The Junior Master Exhibitor Program is an achievement program open to youth from ages 5-18 who are members of Cochins International. Youth membership dues are \$7.50 annually or may be obtained through a family membership of \$15 annually.

Junior Master Exhibitor status is achieved when a junior member earns 5,000 points. Cochins International will award a framed achievement certificate and a zipper hooded jacket with the CI logo for earning Junior Master Exhibitor status.

Points may be earned as follows:

 Joining the Youth Exhibition Poultry Association http://youthexhibitionpoultry.org/ 	100 pts.
2. Complete the YEPA Coop-Tender Book	300 pts.
3. Participate in Youth Showmanship	100 pts. (per show)
4. Obtaining Help from an Adult Mentor	50 pts.

(Juniors can receive points for service such as mentoring another junior, assisting a judge with tallying, helping a club set-up or break-down a show, serve at the Cochin International Club table at a show, etc.)

20 pts. (per task)

- 6. Exhibiting a Bantam or Large Fowl Cochin at an APA/or ABA Sanctioned Junior Poultry Show
- 7. Points will be recorded for the highest placing of each individual bird entered as follows:

•	Entering a Bantam or LF Cochin-	3 pts
•	RV or BV-	8 pts
•	RB or BB-	13 pts
•	Reserve or Class Champion-	20 pts
•	Reserve or Champion Bantam or LF-	30 pts
•	Reserve or Show Champion-	50 pts

Total points will be doubled if earned at an APA or ABA National Show, Cochins International Eastern/ Western
Meet, and Cochins International Regional Meets. Other large shows such as the Ohio Nationals may be added
at the discretion of the Board of Directors.

**Please Note:

5. Service Points-

To receive credit for shows attended and tasks completed, documentation with the signature of the YEPA Club Director, a show secretary, or other adult in authority must be submitted to the CI Junior Director. Examples of acceptable documentation are photocopies of your coop-tags which includes name, date, and location of the show, a showmanship participation form, or a service record form. To receive credit for receiving help from an adult mentor, the person must have several years of experience breeding and exhibiting poultry, and the mentor must submit a signed Adult Mentor form to the junior director on behalf of the junior. If you have any questions regarding how to submit documentation, please contact the junior director. Point forms and logs can be found on the CI website. **All points earned are subject to approval by the Cochins International Board of Directors.**

Pin Program

Juniors may earn achievement pins for Best of Breed and Reserve of Breed wins in either an Open or Junior APA/ or ABA sanctioned show. These pins look great on the lapel of a showmanship coat, show apron or hat! Please submit copies of your coop tags or show report showing the name of the poultry show, date, bird placing and signature of an adult, along with your name and address to your Regional Director or the CI Junior Director.
